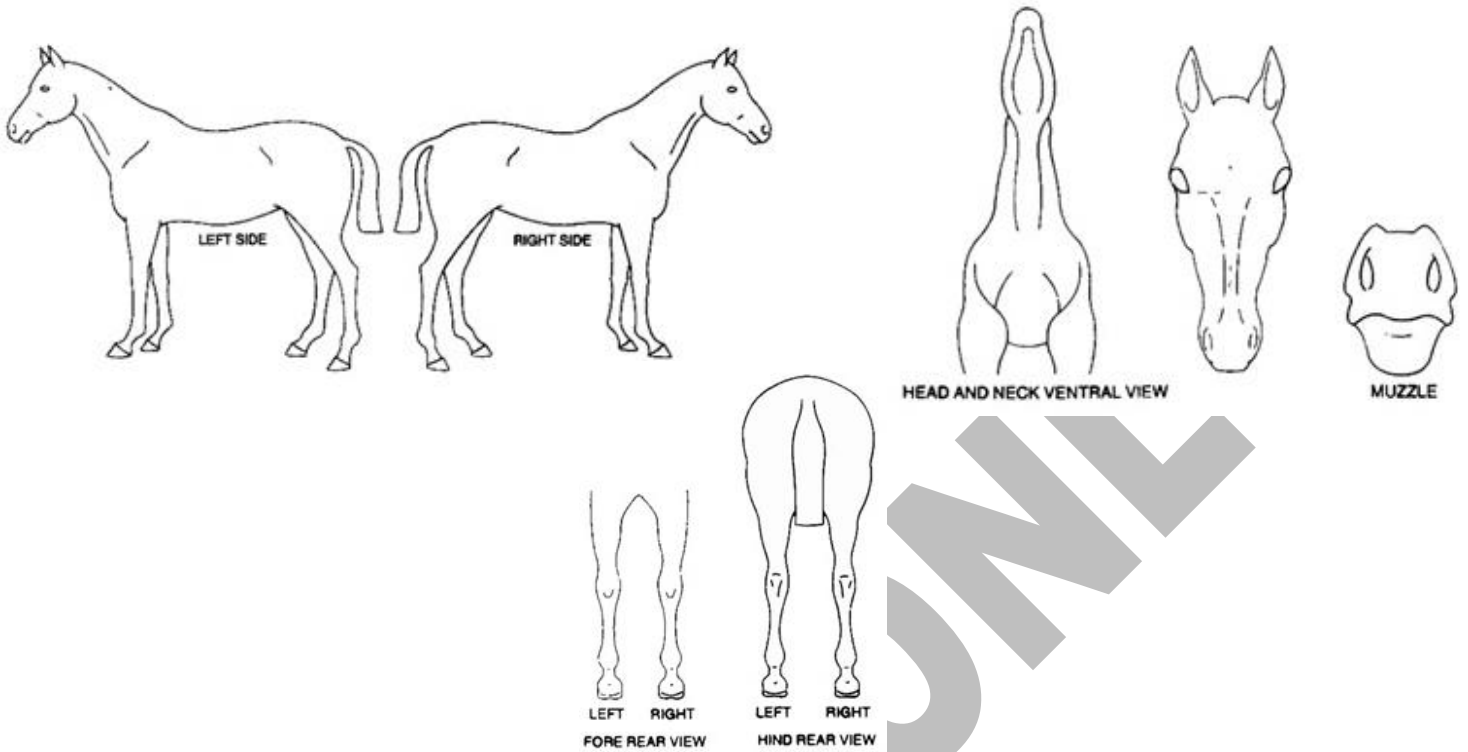

Conditions of Surrender -

____ (initial) I / We, the undersigned, represent and warrant to Sandhills Horse Rescue, hereafter referred to as SHR, their agents, successors, and assigns that I am / we are the sole owner(s) of the above described equine and I / we have full, exclusive, and irrevocable right and authority to surrender ownership of the equine described above.

____ (initial) I / We convey that there are no liens encumber title to the equine, that no other person(s), corporation(s), partnership(s), organization(s), or other private or commercial entity has any legal or equitable right, title, claim, or interest in, against or to the listed equine.

____ (initial) I / We acknowledge and understand that I am / we are transferring ownership, care, custody and control, along with all rights, title and interest in the equine listed herein to SHR for the purposes of rehabilitation, retraining, rehoming, permanent placement or disposition hereafter at the discretion of SHR and that all future decisions regarding the management, treatment, training, and transfer of this equine will be made solely by SHR. I understand that if the equine is found to meet SHR's euthanasia criteria, this may be considered as a final alternative to foster or adoptive placement. I understand that I am permanently forfeiting all right to information regarding the horse's care.

_____ (initial) I / We agree not to perform, cause, or instigate any acts which would adversely affect or interfere with the health and overall welfare of the listed equine and SHR decisions, management, or activities with respect to the listed equine from this date forward.

_____ (initial) I / We, the undersigned, agree to endorse and surrender any registration papers pertaining to the equine listed above. I / We also agree to complete and surrender any and all appropriate and necessary documents required to complete the transfer of ownership for the registration organization so that the registration papers for the equine can be transferred into the name of any subsequent transferee.

_____ (initial) I / We hereby grant SHR and its agents my / our permission to obtain any and all veterinary records pertaining to this equine.

_____ (initial) I / We grant SHR and its agents my / our permission to contact the previous owner of the equine, if listed above.

_____ (initial) I / We hereby agree to indemnify, defend and hold harmless SHR and any related agents, successors, and assigns, from and against any and all losses, damages, deficiencies, claims, demands, suits, actions, liabilities, proceedings, judgments and expenses (including reasonable attorney's fees), and amounts paid or to be paid in settlement, reasonably incurred or suffered SHR, it's agents, successors, and assigns, along with any related parties, in connection with or arising out of the surrender and transfer of ownership of the listed equine to SHR. This is to include any suit, action or other proceeding brought by a third party for acts of the equine owner(s) prior to the date of transfer of the equine to SHR involving any transactions, either directly or indirectly, relating to the listed equine or any suit, action or other proceeding brought by a third party for any damages arising from the use, activities or other transactions in which the listed equine may have been involved, either directly or indirectly, prior to the date of surrender and ownership transfer.

This "Equine Surrender and Transfer of Ownership Agreement" and the rights of SHR and the parties hereunder shall be governed and construed in accordance with the laws of the State of North Carolina.
